Agape Academy Financial Agreement Form

In consideration of Agape Academy accepting an application and making plans to provide sufficient teachers and resources for the education of our child, we the parents agree to the following:

A. All fees (except tuition) are NON REFUNDABLE & NON-TRANSFERABLE unless the school is unable to accept the student. Registration fees will not be refunded once the applicable school year has started. After registration/application fees are paid, if the application is withdrawn by us as the parent of the child, for any reason, we understand that this fee is NOT REFUNDABLE or TRANSFERABLE. However, if we should be required by our employer to transfer from the Little Rock area, the school does agree to refund our application fee only if the applicable school year has not started.

To Parents Regarding Bank Draft Authorization:

Everyone using the monthly payment plan is required to use pre-authorized Automatic Bank Draft Method. Listed below are guidelines that apply to those using the monthly payment plan

1. Pre-authorized bank drafts must be used.
2. **Tuition is due on the 1st of each month** – there is a 15 day grace period.

Accounts must be paid in full by the 15th of each month or a late fee of \$25.00 will be assessed to your account. Returned drafts will be assessed with a \$30.00 return draft fee.

3. Agape Academy will deposit your draft on the exact date you select unless that date falls on a holiday, a weekend, or the office is closed due to inclement weather. In these cases your draft will be deposited on the next business day following your payment date.
4. Include the tuition for all your children on the same draft unless you have separate accounts.
5. Please enclose a **voided check** from your account when you return this completed form to the school office.
6. There is a **\$10.00 charge** to re-process draft application after it has been submitted to MICR Data Systems, Inc.
